Set Up/Breakdown

Vendors may set up on Saturday at 7am-9am. Sellers are responsible for their selling space; please bring your own tables, chairs, and tent. Before leaving, be sure your area is clean and trash free.

Space Allocation

Vendors will be assigned space according to first come, first serve. Placement, flow and competition will be taken into consideration to provide the best experience for attendees. Outdoor 10 x 10 booth space rental is \$25.00. If you have special space needs, please include your request on your application and we will make every effort to accommodate you.

Staff
